The system is actually run with four separate nominal ledgers; three of these are the same company, split into the divisions of: The British Computer Society, Branches and Specialist Groups. The fourth is the British Informatics Society Limited, a subsidiary of the Society.

A future goal is to link the system into the Society's membership system for an integrated solution.
